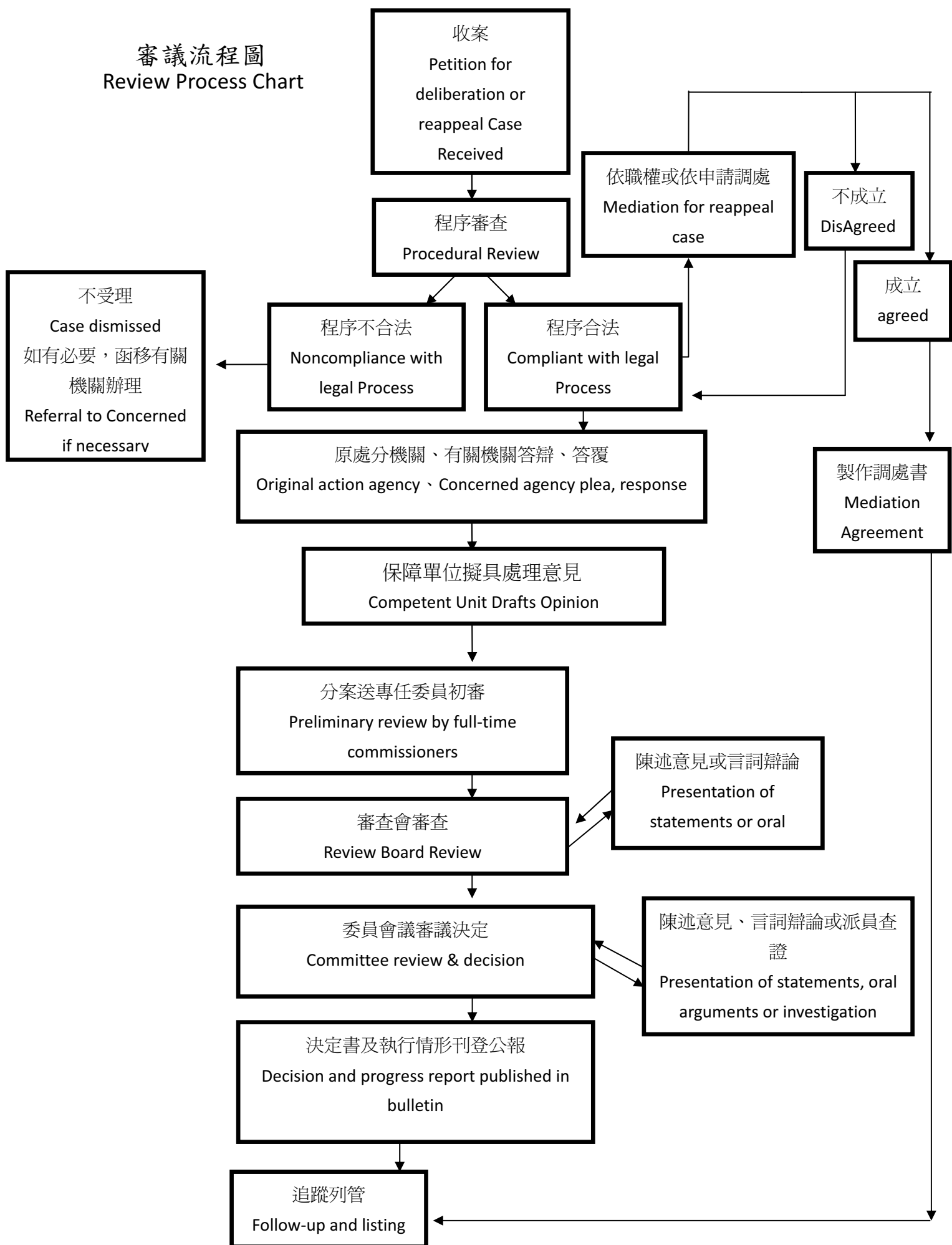


審議流程圖  
Review Process Chart



The handling process for deliberation cases of the CSPTC is as follows:

A civil servant may petition for deliberation case against an adjudication taken by the agency served or the Central Personnel Management Authority (hereinafter referred to as “the original disciplinary agency”), which, he/she thinks is unlawful or obviously illegitimate and causes the infringement of his/her rights or interests. The petitioner shall prepare a Report of Deliberation Case and file it with the SCPTC for deliberation case through the original disciplinary agency within thirty (30) days from the day after the adjudication. When the original disciplinary agency fails to modify or revoke the original adjudication according to the petitioner’s Report of Deliberation Case within twenty (20) days from the next day of the receipt of the Report of Deliberation Case, the agency shall prepare all necessarily related documents and a written defense. After the Report of Deliberation Case is filed with the CSPTC, if matters referred to therein are not under the administration of the CSPTC, a reply shall be given to the petitioner by issuing an administration letter; or the Report of Deliberation Case shall be transferred to relevant agencies to deliberate and a notice thereof shall be given to the petitioner. If matters referred to in the Report of Deliberation Case are under the administration of the CSPTC after the deliberation case is accepted by CSPTC, the Protection Section shall, first, give preliminary handling opinions, which shall be distributed to the appropriate full-time commissioners for preliminary examination, then present them to the Review Board of Protection Cases for review. Finally a decision shall be made at a meeting of commissioners. If necessary, the CSPTC may invite the petitioner or relevant agencies to express opinions or conduct an oral argument, and assign personnel to carry on with an investigation with respect thereto. The Decision on Deliberation made by the CSPTC and its implementation will be publicized on the Examination Yuan Gazette, put under supervision and followed-up.

The handling process for re-appeal cases of the CSPTC is as follows:

A civil servant may file an appeal against the agency's management's action or relevant working conditions rendered by the agency served, which, he/she thinks is improper and damages his/her rights or interests. The appeal shall be filed with the agency served within thirty (30) days from the date after the rendering of the agency's management's action or relevant working condition. If no written reply is submitted by the agency served, the petitioner may file a re-appeal with the CSPTC within thirty (30) days from the day after the date of receipt of the written reply. After the re-appeal is filed with the CSPTC, if matters referred to therein are not under the administration of the CSPTC, a reply shall be given to the petitioner by issuing an administration letter; or the re-appeal shall be transferred to relevant agencies to deliberate and a notice thereof shall be given to the petitioner. If matters referred to in the re-appeal are under the administration of the CSPTC, after accepting the re-appeal, the CSPTC shall, first, give a written notice to relevant agencies and require them to provide the CSPTC with the facts, reasons and present opinions with all necessary related documents within twenty(20) days, then the Protection Section shall give preliminary handling opinions, which shall be distributed to the appropriate full-time commissioners for preliminary examination and submitted to the Review Board of Protection Cases for review. The CSPTC may assign the Vice Minister, one to three commissioner(s) ex officio to mediate during the review of the re-appeal case. Where mediation is successfully completed, the CSPTC shall make a mediation report and put it under supervision and followed-up. Where mediation is not successfully completed, it shall be re-submitted to the Review Board of Protection Cases for review, and a final re-appeal case shall be reviewed and determined at a commission meeting. If necessary, the CSPTC may invite the petitioner or relevant agencies to express opinions or conduct an oral argument, and assign personnel to carry on with an investigation with respect thereto. The Decision on Deliberation made by the CSPTC and its implementation will be publicized on the Examination Yuan Gazette, put under supervision and follow-up.
